Potassium D.L. 0-0-6 is a liquid fertilizer intended for foliar use. It should be used as part of a complete fertilizer program. Plants will require additional sources of major and possibly secondary and minor nutrients. A leaf tissue or soil test should be taken before use. The rate of application depends on soil type and intended crop. Apply Potassium D.L. 0-0-6 foliar at a rate of 4-12 litres/acre (10 – 30 L/ha) with sufficient water for thorough coverage. For best results, spray in early morning or late afternoon. Do not apply when air temperature is above 30°C. Potassium D.L. 0-0-6 is recommended only for a use as a supplementary source of plant nutrients to a basic fertilizer program that relates to the fertility level of the soil.
