TOP-SET D.L. is designed for both foliar and soil use on crops to prevent or correct boron and molybdenum deficiencies. Proper nutrient management will help maximize crop quality and yields. Foliar fertilization is intended to supplement standard ground fertility programs and will not by itself provide all nutrients normally required by agricultural crops.

Directions for Commercial Use:

Foliar: Apply 0.6 - 4.9 L per ha (250ml - 2L per acre) with sufficient water for thorough coverage. For best results spray product in early morning or late afternoon. Do not apply during the "sunlight" hours when air temperature is above 30° C.

Soil: Apply 2.5 - 9 L per ha (1 - 3.5 L per acre). Soil applications can be via conventional ground sprayer or metered through irrigation. Foliar and soil applications are intended to supplement standard ground fertility programs and will not, by itself, provide all nutrients normally required by agricultural crops. This product must only be used for corrections of deficiencies as determined by foliar and soil testing. This product should be applied based on the advice of a government agricultural representative or a professional agricultural consultant.

Mixing: TOP-SET D.L. may be mixed with most fertilizers, insecticides and/or fungicides. A compatibility check is recommended. Materials packaged in water soluble bags should be added to the tank first and completely dissolved before adding any boron containing products to the tank mix - including Top Set DL and Vigor-Cal-Bor-Moly. Check with your agronomic consultant for specific recommendations.

FIRST AID:

IF IN EYES: Hold eyelid open and rinse slowly and gently with water for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call a poison control centre or doctor immediately for treatment advice.

IF ON SKIN: Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes.
